# CZECH FROSTY RABBIT CLUB CONSTITUTION

(Adopted December 12, 2022)

#### ARTICLE I NAME

Section 1. This organization shall be known as the Czech Frosty Rabbit Club; hereafter noted as CFRC.

**Section 2.** It shall be understood that the Czech Frosty rabbit is the rabbit so described in the Standard of Perfection that has been accepted by the American Rabbit Breeders Association (hereafter noted as ARBA).

# ARTICLE II OBJECT

The purpose of the CFRC shall be as stated below.

**Section 1.** To provide a not-for-profit organization for persons interested in maintaining, promoting, and improving the breeding of the Czech Frosty rabbit.

**Section 2.** To promote and conduct private and public exhibitions of Czech Frosty rabbits as well as distribute reliable and authentic information to the public and rabbit breeders regarding the Czech Frosty rabbit.

**Section 3.** To assist the members of this organization in solving problems incident to the breeding and care of Czech Frosty rabbits.

Section 4. To maintain a sweepstakes system for the promotion of Czech Frosty rabbits.

**Section 5.** To provide for Sweepstakes Sanctions at authorized shows and offer special awards to members of the CFRC for specimens exhibited.

## ARTICLE III AFFILIATIONS

Section 1. The CFRC shall be affiliated with the ARBA.

**Section 2.** Any local, state, or district organization chartered by the ARBA may affiliate with the CFRC upon making application to the Secretary of the CFRC along with a copy of their Constitution, By-Laws, Show Rules, and a list of their Board of Directors; and provided the Constitution, By-Laws, Regulations, or Show Rules of such organization do not conflict with the Constitution, By-Laws, or Show Rules of the CFRC, and provided all officers of the applying organization are members of the CFRC and the ARBA.

# ARTICLE IV MEMBERSHIP

**Section 1.** Any person interested in Czech Frosty rabbits may become a member of the CFRC by making application, and upon the payment of dues as provided in the By-Laws, and by agreeing to comply with all rules, regulations, and mandates of the CFRC and the ARBA.

**Section 2.** Application for membership shall be made in writing or electronically to the Secretary and shall be accompanied by dues as provided in the By-Laws. The Secretary will forward the dues to the Treasurer.

**Section 3.** The Executive Board reserves the right to accept or reject, for just cause, any application for membership.

### ARTICLE V OFFICERS

**Section 1.** The Officers of the CFRC shall consist of an Executive Committee (made up of the CFRC Officers) and an elected Board of Directors. The Board of Directors shall consist of at least three (3) other members not on the Executive Committee as well as a Youth Director. The Youth Director is to be under and through eighteen (18) years of age. All Officers, including the Youth Director and except the President, shall have full voting rights. The President shall vote only in the case of a tie vote. All Officers and Directors must be current members of the ARBA and CFRC.

**Section 2.** The Officers shall be elected from and by the CFRC membership by mail or electronic ballot. To be eligible for an office, members must have been a member of CFRC at least one (1) full year just prior to nomination. The Executive Board has the option of waiving the one-year membership requirement.

**Section 3.** The term of office for all Officers shall be two (2) years. The President, Treasurer, and Youth Director shall be elected on even numbered years. The Vice President, Secretary, and remaining Directors shall be elected on odd numbered years. The Executive Board shall consist of the President, Vice-President, Secretary, Treasurer, and all Board of Directors. All officers and directors of this club must be a member of the ARBA and the CFRC or obtain membership before taking office. Failure to obtain or renew such membership shall require them to automatically vacate the office.

**Section 4.** Terms of office shall begin on January 1<sup>St</sup> after elected.

**Section 5.** Vacancies shall be filled by the President with the approval of two-thirds (2/3) vote of the Executive Board. Vacancies are to be filled for the remainder of the officer's term.

**Section 6.** Officers will be automatically removed and replaced if they do not renew their CFRC membership within thirty (30) days of the renewal date. Officers must maintain good standing with both the ARBA and the CFRC.

**Section 7**. The duties of the Officers and Board of Directors shall be those set forth in the CFRC By-Laws, Article V, Sections 1 - 5.

#### ARTICLE VI ELECTIONS

**Section 1.** Any voting member in good standing, wishing to become a candidate for any elective office, shall send the Secretary an Intent to Run. The Intent to Run shall be completed by the member and shall show the member's name and the office for which he/she desires to be a candidate, and shall, in addition, be signed by one (1) member of this association in good standing. The Intent to Run shall be mailed to the Secretary with a postmark of no later than midnight of May 31<sup>St</sup>. The Intent to Run may be sent via email provided another member in good standing sends a separate email to the Secretary stating their support for the candidate. This separate email shall act as their signature on the candidate's petition.

**Section 2.** Upon receipt of the Intent to Run, the Secretary shall determine if the member is eligible to run for office. If eligible, the Secretary shall place the name of the member appearing on the petition and the office for which he/she is a candidate on the election ballot. Any unopposed candidate shall automatically win that office. Write-ins shall not be allowed.

**Section 3.** If any office does not have at least one (1) Intent to Run received by the Secretary, the President shall recommend an appointment to the Executive Board for approval. All recommended appointments must be approved by a simple majority vote of the Executive Board.

**Section 4.** The Secretary shall prepare paper or electronic ballots yearly and use first class postage when mailing all ballots to all eligible members in good standing by June 30th. All ballots shall be returned to the Election Chairperson. All returned ballots must be postmarked no later than July 31st to be considered valid. The Election Committee shall count all acceptable ballots by August 15th and send a certified statement of the results along with the ballots to the Secretary. Facsimiles or copies of the official ballot shall not be considered an acceptable ballot and shall be declared void. Voided ballots shall be held by the Secretary, along with the valid ballots, for a period of one (1) year. The statement and the returned ballots shall be retained for one (1) year.

**Section 5**. The candidate with the highest number of votes on the acceptable ballots shall be declared the winner. In the event of a tie between two (2) or more persons for the same office: the Executive Board, prior to the annual meeting shall vote on the winner. The Secretary shall notify the candidates of the election outcome by August 30th.

**Section 6**. New officers and Board members shall take over their respective duties on January 1<sup>st</sup> following the election.

**Section 7.** In the case of an uncontested election, the Secretary shall cast a lone ballot and the election will be official.

**Section 8.** Whenever a vacancy in an office occurs, from any cause whatsoever, said vacancy shall be filled by appointment by the President, approved by majority vote of the Executive Board.

**Section 9.** No person may hold more than one elected office at a time.

**Section 10**. Any candidate defeated for any office of the CFRC and requesting a recount of ballots shall make application for such recount to the Secretary within thirty (30) days following the election.

## ARTICLE VII MEETINGS

**Section 1.** The Annual CFRC membership meeting shall be held in conjunction with the annual ARBA National Convention, such place to be designated by the Executive Board. Notice of time and place for holding such meetings shall be set forth in writing by the CFRC at least thirty (30) days prior to the date of such meeting and given to the membership by way of the newsletter, electronically mailed, and placed on the CFRC website and social media pages. In addition to the Annual Convention held in conjunction with the annual ARBA National Convention.

**Section 2.** The CFRC may also hold a meeting at the National Czech Frosty Show, with such place to be designated by the Executive Board. Notice of such meeting shall be set forth in writing by the CFRC at least thirty (30) days prior to the date of such meeting and distributed to the membership as explained in Article VIII Section 1 of the Constitution.

**Section 3.** In the absence of such an Annual meeting, as described in Article VII Section 1 club business shall be conducted and acted upon by the Executive Board by mail or a recorded means of communication if deemed advisable. This recorded means of communication can include but is not limited to electronic correspondence, teleconference, and video conference. Decisions and votes are to be reported in the Secretary's minutes, in the newsletter, and on the CFRC social media (Facebook, website, Twitter, etc.).

**Section 4.** Other specifications regarding the CFRC Meetings shall be found in and are incorporated within Article IV of the CFRC By-Laws.

# ARTICLE VIII INTERPRETATION AND DISCIPLINE

- **Section 1.** The interpretation by the CFRC Executive Board of the Constitution, By-Laws, Regulations, Notices, Resolutions, Properties, and of the CFRC documents and Orders shall be binding upon all members of the CFRC.
- **Section 2.** Charges of misconduct may be filed by a member against any other member. Charges must be filed with the Secretary in writing. This document must provide full details in support of the grievance filed.
- **Section 3:** In the event of preferment of charges, the member against whom the charges have been filed shall be furnished a complete statement of the charges by the Secretary and shall be allowed thirty (30) days to file a reply.
- **Section 4:** The charges, together with the reply (if received), shall be furnished to each member of the Executive Board for their consideration.
- **Section 5:** The Executive Board may, by a two-thirds (2/3) vote suspend or expel the member. Less than two-thirds (2/3) vote shall constitute an acquittal of the charges.
- **Section 6:** Any member or persons suspended, expelled, or otherwise rejected shall not be eligible for reinstatement for a period of at least one (1) year from the time of suspension or expulsion. The Executive Board must authorize reinstatement by a two-thirds (2/3) vote.
- **Section 7:** Any Officer who shows a lack of interest in his official duties or who fails to answer correspondence on club matters from his fellow officers shall be asked by the President and/or Executive Board to resign said office.

# ARTICLE IX ALTERATIONS AND AMENDMENTS

- **Section 1.** Any alteration of, or amendment to, the Constitution, By-Laws, or Sweepstake Show Rules, shall be made by a resolution via one of the following methods ninety (90) days prior to the CFRC Annual meeting so that it may be posted for the required thirty (30) days before the CFRC Annual meeting:
  - A) Resolution in writing signed by three (3) or more members in good standing of the CFRC and delivered to the Secretary and Executive Board; or
  - B) Resolution by the Constitution and By-Laws Committee with approval by two-thirds (2/3) vote of the Executive Board.

Section 2. Any proposed Resolution shall be confined to one (1) subject.

**Section 3.** The Constitution, By-Laws, or Sweepstakes Show Rules may be amended by a two-thirds (2/3) majority of all eligible voting members present at the annual meeting providing that all members have been notified in writing of the proposed changes at least thirty (30) days prior to the annual meeting. The item to be considered must appear on the agenda of the meeting.

Section 4. Amendments will take effect thirty (30) days after the vote is recorded.

# ARTICLE X AUTHORITY

**Section 1.** The CFRC shall have the authority to make such laws, establish such rules and adopt such regulations as may be necessary for the government of its members.

**Section 2.** Robert's Rules of Order Newly Revised shall be considered as the final authority for the CFRC on all questions not specifically covered by the Constitution and By-Laws.

**Section 3.** The CFRC shall require its members to obey its mandates in all matters pertaining to the Standard of Perfection and ethics peculiar to the industry, and to inflict such punitive penalties as it may deem necessary for the disobedience of its will, provided that its members shall not be required to commit any act which would make them amenable to the laws of the United States of America or any political subdivision thereof.
